For good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. The Ambassador hereby acknowledges that the Ambassador may participate in competitions, conferences and/or seminars and, from time to time, attend The Institute of Chartered Accountants of Ontario, a not-for-profit corporation incorporated under the laws of the Province of Ontario, at its office located at 69 Bloor Street East, Toronto, Ontario, Canada, M4W 1B3. The Ambassador hereby acknowledges that all information relating to the ICAO's competitions, conferences and seminars can be found on the ICAO's website at <http://www.guidetorulingtheworld.ca>.
2. The Ambassador hereby consents to the ICAO and its successors, or third parties or others working for or on its behalf, including officers, directors, agents, and any publishers, advertising agencies, promotional agencies or other media, storing and using the personal information of the Ambassador submitted for the purpose of enrolling with the ICAO and its administering competitions, conferences and/or seminars.
3. Subject to Section 4, below, the Ambassador hereby gives permission to the ICAO and its successors, or third parties or others working for or on its behalf, including officers, directors, agents, and any publishers, advertising agencies, or other media to reproduce, copy, publish, or otherwise use his or her likeness and name throughout Ontario in video, internet, printed literature and print ads appearing in university student club publications, and to reproduce, copy, publish, or otherwise use his or her likeness and interview content, as is or as may be reasonably retouched or edited, as taken from a photograph, videotape or any material based upon or derived therefrom.
4. The ICAO agrees that the use for which permission is given is limited to recruitment and related purposes, and that it will make no other use of the Ambassador's image and related material without prior written permission of the Ambassador.
5. The Ambassador agrees that the ICAO has the right, in its sole discretion, to require proof of identity and/or eligibility from the Ambassador prior to accepting the application. The Ambassador acknowledges that failure to provide such proof in a timely manner may result in the Ambassador's application being denied.
6. The Ambassador agrees and acknowledges that the Ambassador has no claim for any compensation or benefit from the ICAO or any party acting on its behalf, arising from this agreement.
7. Provided that the ICAO complies with all of its obligations as set out above, the Ambassador agrees to release, indemnify, and hold harmless the ICAO and its successors, its members, officers, directors, and agents, from any claims, damages, injuries, costs, or actions, including without being limited to, any claim based on invasion of privacy, defamation, breach of intellectual property rights, or right of publicity incurred or arising as a result of this agreement or the Ambassador's breach of any term of this agreement.
